ACCEPTANCE OF MERCHANDISE: Nicole's Consignment, LLC reserves the right to only accept and sell items we determine to be sellable. Items that are missing parts or broken will not be accepted. All items must be clean, in good condition, currently in style and in demand. We will not accept items housed in a smoking or pet environment. We reserve the right to refuse items due to condition or current inventory levels. At time of intake, staff will screen items and explain policies.

CONSIGNMENT PERIOD and TERMS:

- Consignment term is **90 days**. (*Items removed from inventory prior to 90 days may be subject to \$25 fee or 25% of the list price, whichever is greater*).
- Commission split is **50/50**.
- Small items** may be brought to Nicole's Consignment **Monday - Saturday 10am - 5pm**.

PRICING:

- Pricing is based on previous sales of like items.**
- Items will automatically reduce **15% each 30 days**.
(We reserve the right to negotiate on your behalf).
- Seasonal merchandise will be reduced until sold.

EXPIRED ITEMS:

If your items have not sold at the end of the 90-day period:

1. Pick up your items during the **10 day grace period between 90 and 100 days**. For multiple items, please call the shop ahead of time for assistance.
2. Expired items sold for greater than \$100 will be paid commission.

CONSIGNOR PAYMENTS & FEES: A **one-time \$10 account set-up fee** will be deducted from your first check. Consignor's checks will be ready for pick-up at Nicole's on the **15th of each month for the previous month's sales that generated a minimum of \$20**.

MAIL CHECK FEE: For consignors who live out of town, checks are mailed on the 15th of each month and will have \$2 deducted to cover postage and handling.
